



***IP WEB VISITOR™* Privacy Policy**

This IP Web Visitor™ Privacy Policy (this “Privacy Policy”) describes how IP Web Visitor™ (“we” or “us”) uses and protects any information that you provide when you use the www.IPWebVisitor.com website (the “Website”).

We are committed to ensuring that your privacy is protected. You can be assured that if we ask you to provide information by which you can be identified, we will use that information only in accordance with this Privacy Policy.

We may amend this Privacy Policy at any time by posting the changes and/or the revised policy on the Website. Your access or use of the Website after the posting of any such changes or modifications indicates your acceptance of the policy, as revised.

Information We Collect

We collect personally identifiable information including your first and last name, e-mail address, mailing address, agency and title, and driver’s license information in order to provide you with a Website account (“Account Information”). In addition to this personally identifiable information, we may also gather technical data that is transmitted between your computer and the Website such as your IP address, operating system, and browser type.

How the Information Is Used

Account Information is required by the correctional facilities for your registration and use of the Website and will be provided to the correctional facilities. We do not share, sell, trade, or distribute your information to any party other than the correctional facilities with whom you choose to register. Notwithstanding the foregoing, we reserve the right to use or disclose any Account Information as needed to satisfy any law, regulation, or legal request, to protect the integrity of the Website, to fulfill your requests, or to cooperate in any law enforcement investigation or an investigation on a matter of public safety.

Credit card transactions are handled by a third party financial institution and its vendors (collectively, the “Financial Institution”), which receive your credit card number and other personally identifiable information for the purpose of verifying your credit card number and processing payment transactions. The Financial Institution will have access to your personally identifiable information if you make a purchase via the Website using a credit card. **[We do not store your credit card information in our system, but the Financial Institution may do so in accordance with its policies.]**

We do not control the privacy policies of the individual correctional facilities or the Financial Institution. We are not responsible for any actions taken by any correctional facility or by the Financial Institution with respect to Account Information or any other personally identifiable information.

How We Use Cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you accept a cookie, the file placed on your computer's hard drive helps analyze web traffic, lets us know when you visit a particular website, and/or allows web applications to respond to you as an individual by tailoring their operations to your needs, likes, and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used on the Website. This helps us analyze data about web page traffic and allows us to improve the Website to address customer needs. We only use this information for statistical analysis purposes and the data is then removed from our system. Cookies do not give us access to your computer or any personally identifiable information about you, other than the data you choose to share with us. You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but users can typically modify browser settings to decline cookies. Declining cookies may prevent you from taking full advantage of the Website and may cause certain features of the Website not to function.

Links to Other Websites

The Website may contain links to other websites not operated by us. If you visit one of these linked sites, you should review its privacy and other policies. We are not responsible for the policies and practices of other companies or websites, and any information you submit to those companies or websites is subject to their privacy policies. We are not responsible for the protection and privacy of any information you provide while visiting such external websites.

Children's Privacy

The Website is not designed or intended to attract or to be directed to children under the age of 13. We do not collect any personally identifiable information, whether or not such information is voluntarily provided, from any person we actually know is under the age of 13. If we are made aware that we have actually collected information about a person under the age of 13 without requisite and verifiable parental consent, we will remove that information from our records in a timely fashion, provided, however, that if a visit has been scheduled or has occurred before we are notified that a user is underage, the individual correctional facility may retain such information in its systems as required by law and its own visitation policies.
